ORDER

In terms of Section 14(1) of the NCTE Act, 1993 Miranda Education Society, Bangalore, Karnataka had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Miranda College of Education, C.A.52, HAL 3rd Stage, Indiranagar, Bangalore-560075, Karnataka for Secondary(B.Ed) Course of one year duration from the academic session 2004-05 with an annual intake of 100 students.

- 2. On scrutiny of the application submitted by, the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
 - The institution has acquired the land for setting up the teacher education a. institution.
 - b. The institution has constructed the building for conducting the course on the above mentioned land.
 - The institution has created an Endowment Fund of Rs.5 lakhs and a C. Reserve Fund of Rs. 3 lakhs.
 - The institution has selected the Principal and Seven lecturers for the d. said course and the list of faculty members has been approved by the affiliating University.
- 3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Miranda College of Education, C.A.52, HAL 3rd Stage, Indiranagar, Bangalore-560075, Karnataka for Secondary(B.Ed) course of one year duration from the academic session 2004-2005 with an annual intake of 100 students subject to fulfillment of the following.
 - The institution will ensure that Principal and Seven faculty members duly a. approved by affiliating University are in position for an intake of 100 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately and in any case not later than one month from the date of commencement of the course.

- b. The institution shall, within one month of the receipt of recognition order, convert the Endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
- c. The institution shall shift to its own premises / building within three years from the date of recognition. (in case the course is started in rented premises)
- d. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the affiliating University, UGC, State Government etc.
- 5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
- 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act, 1993.

WHEREAS, the recognition was granted to the institution namely, Miranda College of Education, C.A. 52, Hal 3rd Stage, Indiranagar, Bangalore, Karnataka-560075 run by Miranda Education Society, Bangalore, Karnataka vide SRC order No. F.SRO/NCTE/B.Ed./2004-2005/8723 on 29.11.2004 for conducting Secondary (B.Ed.) course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit on 21.01.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 16.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the SRC in its 388^{th} meeting held on $14^{th}-15^{th}$ September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per decision of SRC Show Cause was issued to the institution on 23.02.2021. The institution has submitted reply on 10.03.2021.
- **4. AND WHEREAS,** the SRC in its 403rd meeting held on 18th 19th October 2021 considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 03.11.2021. The institution has submitted reply on 15.11.2021.
- 5. AND WHEREAS, the SRC in its 405th Meeting held on 13th & 14th December, 2021 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Miranda College of Education, C.A. 52, Hal 3rd Stage, Indiranagar, Bangalore, Karnataka-560075 for B.Ed. programme for 2 basic units of 50 students each."

6. NOW THEREFORE, this order is issued permitting the institution i.e., Miranda College of Education, C.A. 52, Hal 3rd Stage, Indiranagar, Bangalore, Karnataka-560075 run by Miranda Education Society, C.A. 52, Hal 3rd Stage, Indiranagar, Bangalore, Karnataka-560075 for Continuation of recognition for B.Ed. programme for two years duration with an
